- VI. New Business
 - A. New Transportation Alternatives Set-Aside (TA) Program Projects

The Transportation Alternatives (TA) Set-Aside provides funding for programs and projects defined as transportation alternatives. These include on- and off-road pedestrian and bicycle

facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation; recreational trail projects; safe-routes-to-schools projects; and projects for planning, designing, or constructing boulevards and other roadways largely in the right-of-way of former divided highways.

Two projects will be presented at the meeting. They are the *Ala Wai Bridge Project* which will include a new pedestrian and bicycle bridge over the Ala Wai Canal and the *Rail Station Multimodal Access Improvements – Halawa Station and the Waiawa Station* which consists of planning design and construction of multimodal access improvements to the Halawa Aloha Stadium Rail Station and Waiawa Pearl Highlands Rail Station which will provide multimodal access to the two stations and the whole rail system. The two presented projects are both being recommended for funding by the TA Evaluation Committee.

Requested Action: Approve the two new projects presented for Transportation Alternatives Set-Aside Program funding.

B. Oahu Regional Transportation Plan (ORTP) 2045

The O'ahu Regional Transportation Plan (ORTP) is a long-term document that outlines transportation vision, goals, objectives, policies, and projects for O'ahu. The 25-year horizon of the plan incorporates forecasted population, housing, and employment changes, as well as information about O'ahu's existing transportation system. It also identifies specific highway, transit, freight, bicycle, and pedestrian projects that are designed to improve safety, mitigate congestion, and increase mobility for O'ahu's residents and visitors, within a financially constrained budget. Projects that are in the ORTP are eligible for federal transportation funding.

Requested Action: Approve the 2045 O'ahu Regional Transportation Plan as presented.

C. Mahoe Street Reclassification

FHWA defined functional classification as "the process by which streets and highways are grouped into classes, or systems, according to the character of service they are intended to provide. Basic to this process is the recognition that individual roads and streets do not serve travel independently in any major way. Rather, most travel involves movement through a network of roads. It then becomes necessary to determine how this travel can be channelized within the network in a logical and efficient manner. Functional classification defines the nature of this channelization process by defining the part that any particular road or street should play in serving the flow of trips through a highway network."

The City's Department of Transportation Services will present their case requesting the Policy Board's concurrence on reclassifying Mahoe Street from a Local Road to a Minor Collector.

Requested Action: Policy Board concurrence of the reclassification of Mahoe Street from a Local Road to a Minor Collector.

D. Establish a Permitted Interaction Group (PIG) to Manage the Executive Director Evaluation Process

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) 2014 and 2018 Certification Reviews recommended the establishment of formal performance reviews for the Executive Director. The Policy Board will discuss criteria, structure, and procedures for the performance of the evaluation of the Executive Director and establish a Permitted Interaction Group to conduct the evaluation.

Requested Action: Establish a permitted interaction group (PIG) to conduct the evaluation process of the OahuMPO Executive Director. Direct the PIG to develop the evaluation process based on the criteria decided upon at this meeting, to compile the results of the performance evaluations received from the evaluators who will be invited as decided at today's discussion, and to report back to this Policy Board at a future meeting.

E. Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) Funding Proposal

The State of Hawaii received ~\$42 million in funds from the Coronavirus Response and Relief Supplemental Appropriations Act (CRSSAA) for Highway Infrastructure Programs (HIP). Of this amount, about \$6 million has been sub-allocated to Oahu as a Transportation Management Area (TMA).

Funds resulting from this apportionment are available for obligation until September 2024. They are not subject to obligation limitation and do not need to be on the ORTP or the TIP. The Federal share payable shall be up to 100 percent, so no local match is required. The eligibility of these funds allows non-traditional uses, such as routine maintenance, operations, personnel costs, debt service, etc.

FHWA's Implementation Guidance for CRRSAA funds states that the OahuMPO Policy Board is responsible for selecting projects for HIP-CRRSAA funding in the TMA in consultation with the State and any affected public transportation operator. HDOT will present a proposal for the use of the CRRSAA funds sub-allocated to Oahu. The proposal is for the design and construction of a left-turn lane from Pearl Highlands Rail Station on Kamehameha Highway to Kuala Street.

Requested Action: Policy Board concurrence of HDOT's proposal to use the ~6million TMA Suballocation of CRRSAA funds for the design and construction of a left-turn lane from Pearl Highlands Rail Station on Kamehameha Highway to Kuala Street.
