TIP FFYs 2022-2025 Revision 16

The OahuMPO completed the Transportation Improvement Program Federal Fiscal Years 2022-2025 Revision 16 (TIP FFYs 2022-2025 Revision 16), which was an Administrative Modification involving minor changes to thirty-four existing projects that will be incorporated as is into the next revision of the Statewide Transportation Improvement Program (STIP). TIP FFYs 2022-2025 Revision 17

Transportation Improvement Program Federal Fiscal Years 2022-2025 Revision 17 (TIP FFYs 2022-2025 Revision 17) is an Amendment involving major changes to one existing project, the removal of two existing projects, and considerations for five new projects from the Oahu Regional Transportation Plan (ORTP). The OahuMPO held a two-week public and intergovernmental review period which ended on January 17, 2024. We received a total of 16 comments which have been shared with the responsible agencies for the projects. The agencies have two weeks to respond to the comments so if you haven't done so already, please submit your responses to our Senior Transportation Planner, Dallas Ige, by 5:00 PM on Wednesday, January 31, 2024.

They also received a presentation on TIP FFYs 2022-2025 Revision 17 and a review of TIP FFYs 2025-2028 Project and Program Scoring.

Technical Advisory Committee (TAC)

The TAC met on Friday, January 12. They held elections for a new Chair and Vice Chair for 2024. Ian Crittenden of DTS was elected to serve as Chair, and Masatomo Murata (HDOT) was reelected to serve as Vice Chair.

They received a presentation on the Anonui Street Functional Classification Request by DTS and voted to recommend the Policy Board approve DTS' request to assign a functional classification to Anonui Street.

They also received presentations on the Transportation Improvement Program (TIP) Federal Fiscal Years (FFY) 2025-2028 Project and Program Scoring Review, the 2024 Transportation Project Management Training Program, the Transportation Management Area (TMA) Certification Review Action Items, and the OahuMPO Strategic Plan Action Items.
