A. Overall Work Program (OWP) Presentation: Planning for Improved Resilience to Coastal Hazards through Green Infrastructure

The State Climate Change Mitigation and Adaptation Commission, in coordination with the Department of Land and Natural Resources, received OWP funding to conduct a feasibility assessment of green infrastructure to protect Kamehameha Highway and restore the beach in Punalu'u. The project tasks included geo and biotechnical surveys and outreach to the local community. The project consultant will present the findings of the study.
